SELF CONTAINED HOT TUBS

PLACEMENT

Utility Wiring

1. Underground utilities shall not be located within 5 feet of the tubs edge.
2. Overhead utilities shall not be located within 10 feet of the tubs edge

Location in relation to property line and other structures on the property.

3. Hot tubs shall not be placed in any easement areas.
4. When placed near other structures on the property consideration should be made to the manufactures recommendations. Provide adequate clearance for the service of this equipment.
5. Any windows located within five (5) feet of a hot tub, whirlpool, or saunas edge where the bottom exposed edge of the glazing is less than 60 inches measured above grade will require these windows to be constructed of tempered glass.

Electrical (2008 NEC – with amendments)

6. All electrical shall be installed in conduit and approved for the environment in which it is placed. EMT type conduit is not permitted at the exterior to the home were subject to moisture.
7. Wiring shall be sized in accordance with the manufactures installation instructions and be rated for the environment in which is placed.
8. GFCI protection shall be provided for the circuit providing power to the tub with a means of disconnection provided within sight of this equipment. It is recommended this disconnection point be labeled as hot tube disconnect.
9. No receptacle outlet shall be located within six (6) feet of the hot tubs edge.
10. A GFCI protected receptacle outlet shall be provided for general service and located no closer than six (6) feet and no greater than twenty (20) feet from the tubs edge.
11. Any receptacle outlet located within twenty (20) feet of the tubs edge shall be GFCI protected.

Barriers

12. Hot tubs not provided with approved covers using functional locking straps meeting the requirements of **ASTM F 1346** shall be provided with barriers as required for swimming pools.

Standards

13. Portable spas and hot tubs shall be designed and constructed in conformance with ANSI/NSPI-6
