Addendum #2 is hereby released to the changes listed below.

1. Delete Section V, Paragraph E in its entirety and replace with the following:

“E. MULCHING – All mulch spread is not to exceed 2-3 inches. Brown, shredded hardwood mulch will be applied during the spring cleanup. Mulch shall be applied to all perennial, shrub and tree beds.”

2. Delete section XI on page 9 Wage Rate Requirements in its entirety and replace it with the following:

“WAGE RATE REQUIREMENTS

A. The type of work under this contract is not prevailing wage work.

B. A copy of the wage determination shall be posted by the Contractor in a conspicuous place at the site of the work where it can be easily seen by the workers.

C. The Contractor shall maintain certified time sheets and submit to the Village with final invoice.

D. The Contractor will be required to sign a Wage Rate Requirement Certification.”

3. Delete the Wage Rate Requirements Certification on page 12 in its entirety and replace with the following:

“WAGE RATE REQUIREMENTS CERTIFICATION

GENERAL

1. The Prevailing Wage Law does not prohibit payment of more than the prevailing rate of wages nor does it limit the hours of work which may be performed by any worker in any particular period of time.
2. The Contractor shall maintain certified time sheets and submit to the Village with final invoice.


13. Intersection, IL Rte 71 & Douglas St, NE Quadrant


28. US Rte 34, N .Side, BPH to Chesterfield
