

## **BUSINESS REGISTRATION**

### **3-1-1: BUSINESS SUBJECT TO REGISTRATION:**

All persons conducting any type of business within the village shall obtain a permit annually to operate said business. The word "person" as used in this chapter means any individual person, firm, corporation, partnership or association which operates or maintains any type business within the village. (Ord. 93-22, 10-4-1993)

### **3-1-2: APPLICATION FORM:**

The application forms for said permit shall be obtained from the village and shall be executed in duplicate under oath by said applicant. All information requested on said form shall be filled in by applicant. Any application for registration to conduct a family daycare home, group daycare home or daycare center shall be accompanied by a license issued by the state for the operation of such business. (Ord. 06-43, 4-10-2006)

### **3-1-3: CLASSIFICATION; FEES:**

- (A) All businesses within the village of Oswego shall be classified within the B-1, B-2, B-3, M-1 and M-2 zoning classifications as defined in the village of Oswego zoning ordinance with the exception of home occupation businesses.
- (B) The initial registration fee for said permit for any and all businesses located within the B-1, B-2, B-3, M-1 and M-2 zoning classifications as regulated by the adopted zoning ordinance of the village of Oswego shall be fifty dollars (\$50.00) and shall be payable to the village at the execution of the application form by the applicant. The annual renewal registration fee shall be twenty five dollars (\$25.00).
- (C) The initial registration fee for any home occupation business as regulated by the adopted zoning ordinance of the village of Oswego shall be twenty five dollars (\$25.00) and shall be payable to the village at the execution of the application form by the applicant. The annual renewal registration fee shall be ten dollars (\$10.00). (Ord. 06-43, 4-10-2006)

### **3-1-4: DURATION OF REGISTRATION:**

The permit shall be issued for a one year period or any part thereof and permits shall run from January 1 to December 31 for each calendar year. (Ord. 06-43, 4-10-2006)

### **3-1-5: POSTING OF REGISTRATION:**

The permits issued under this chapter shall be posted in a prominent location on the business premises. (Ord. 06-43, 4-10-2006)

### **3-1-6: PENALTY:**

Any person found liable/guilty by a preponderance of the evidence of a violation of this chapter in an administrative/judicial hearing shall be subject to a class I fine, plus applicable hearing costs, as provided in subsection 1-4-3(D) of this code. (Ord. 09-42, 5-12-2009)

### **3-1-7: SEPARABILITY:**

Any section or provision of this chapter that is construed to be invalid shall not affect the remaining sections or provisions which are deemed separable, to which shall remain in full force and effect thereafter. (Ord. 93-22, 10-4-1993)
